Message from the Executive Director

Kimberly A. Mealy is executive director of the American Political Science Association, having been appointed to the role by the APSA Council in fall 2024. Prior to her appointment, Dr. Mealy served on the APSA senior leadership team, and in the staff director position prior to that. She has been with the association since 2007. Dr. Mealy holds a PhD from Indiana University, Bloomington, in political science and political cognition.

In 2024, APSA achieved several significant milestones across multiple initiatives, including reinforcing our commitment to advancing political science research, education, and professional development and providing resources for scholars. APSA's wide range of programs and fellowships continued to provide critical support for scholars, educators, and students.

The 120th APSA Annual Meeting in Philadelphia, PA, brought together 6,596 attendees, fostering discussions on "Democracy: Retrenchment, Renovation, & Reimagination." In the spring of 2024, APSA hosted its first annual Virtual Research Meeting, which expanded access to scholarly collaboration through virtual research groups. APSA Teaching and Learning programs provided vital resources for educators through webinars and APSA Educate. Internationally, APSA strengthened partnerships with organizations in Brazil, Japan, and the MENA region to support early-career scholars. These accomplishments underscore APSA's dedication to fostering an engaged and connected political science community. APSA has leveraged many opportunities to engage and collaborate with the membership and the broader discipline through the promotion of innovative programming, support for research and scholarship, and resource provision for students, teachers, scholars, and practitioners alike.

APSA's accomplishments over the 2024 fiscal year reflect the association's ongoing commitment to supporting political science scholars, students, and practitioners, as well as political science research, education, and public engagement. Through innovative programming, expanded professional development opportunities, and strengthened global collaborations, we continue to provide valuable resources for scholars at all career stages.

APSA is very fortunate to have many dedicated members who generously devote their time and resources to supporting our extensive programming, including the annual meeting and multiple leading scholarly publications. I look forward to working with our members in the coming year as we continue developing programs that advance research, pedagogy, professional development, and public engagement. Additionally, I would like to express my gratitude to former Executive Director, Dr. Steven Rathgeb Smith, who retired in September 2024, for his dedicated leadership and excellent stewardship of the association for the past eleven years. I am grateful for the leadership of the APSA Council, the service of the numerous governance and standing committees, and the dedication of our members, staff, and partners who help to support the association's strategic mission and values. I look forward to continuing to lead the association in advancing and achieving our shared mission and goals for the political science profession.

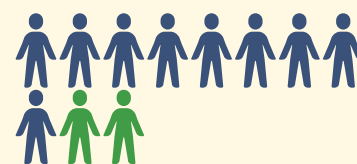
Individual Membership

In August 2024, APSA launched a pilot eJobs Signaling Initiative. Through this program, job seekers were able to transmit or signal their interest in receiving an interview (or moving forward with the next step in the application process.) to departments that had active listings posted to eJobs.

Job seekers were able to submit up to 3 signals to departments. Throughout the 2 weeks that the program was open, 273 signals were submitted.

Benefits of APSA eJobs

[APSA eJobs](#) is the most comprehensive database of jobs related to political science, accessible to members. APSA departmental members have access to post and view job listings on our eJobs site as a part of their departmental membership.

As a benefit of departmental membership, departmental members may search for and post job listings as well as view and search candidate CVs.

In 2024, 9 political science departments participated in the External Review Program. There are 26 departments currently sponsoring 451 student memberships through APSA's department-sponsored membership program.

APSA Annual Meeting & Exhibition (2024)

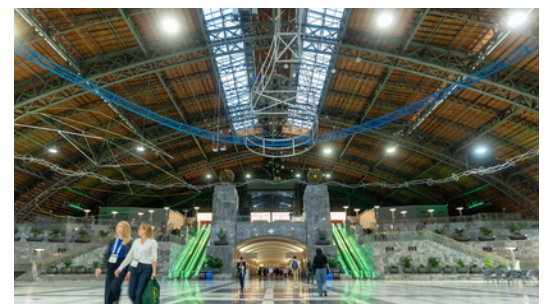
Political scientists joined the American Political Science Association for the [120th Annual Meeting & Exhibition](#) in Philadelphia, PA, from September 4-8, 2024. The panels centered around the Program Chair's, Danielle Allen and Michael Neblo, meeting theme, "Democracy: Retrenchment, Renovation, & Reimagination."

Attendees heard from APSA President Dr. Mark E. Warren, University of British Columbia, as he gave the 120th APSA Presidential Address: "Democratic Innovation and Representative Democracy." The program addressed a range of significant and timely issues including those highlighted in the plenary and breaking news panel discussions: "Democracy, Retrenchment," "Democracy, Renovation and Reimagination," "AI and Democracy," "Future of Political Parties," and "Implications of the Israel-Gaza Crisis for the Middle East and Beyond."

Following the success of the 2023 Film Festival, a [Film Showcase](#) was incorporated into the 2024 meeting, showcasing an advanced screening of "War Game," sponsored by the [APSA Graduate Student Committee](#), followed by a Q&A with the cast of the film and political science scholars. Additionally, the APSA Oral History Project films were also shown, providing attendees the opportunity to view a collection of interviews that seek to amplify the contributions of Black, Indigenous, and People of Color to the political science profession.

The meeting also featured the [5th Annual Emerging Scholars Symposium](#) where undergraduate and graduate students had the opportunity to present in a Lightning Round format. Emerging scholars also had the opportunity to attend the Graduate School Information Fair and Graduate Student Happy Hour in Philadelphia.

The 2024 meeting also featured 62 poster sessions with nearly 300 unique iPosters, including a particularly well-attended poster session from the 50 Years of LGBTQ Scholarship at APSA Mini-Conference. Additionally, APSA provided 88 travel grants to attendees. Members and attendees who required childcare to attend the meeting and applied for childcare reimbursement received up to \$500.

The [2024 APSA Annual Meeting](#) also featured over 1600 total events, including over 1,400 panels (including 62 poster sessions) and 169 affiliated events (94 business meetings and 75 receptions), providing a forum for over 6,500 attendees to present their cutting-edge research and innovations in the political science discipline, as well as providing the opportunity to network and collaborate with one another.

APSA Annual Meeting attendees took part in more than 1,400 panel sessions, explored the Exhibit Hall, and participated in the [Career Open House](#), business meetings, and receptions in Philadelphia.

TLC at APSA (2024)

The seventh bi-annual Teaching & Learning Conference at APSA ([TLC at APSA](#)) was held on Saturday, September 7, on the theme of “Teaching Democracy: Reflection, Innovation and Imagination.” TLC at APSA, a full day event, brought over 130 Annual Meeting attendees together for plenary and workshop sessions.

Four tracks were featured this year, focusing on Reimagining Civic Engagement, Innovations in Active Learning and Democracy, 21st Century Skills: Literacy, Analysis, Research and Writing, and Equity, Diversity, Inclusion, Justice, and Accessibility. The TLC at APSA plenary was delivered by Nazita Lajevardi (Michigan State University) on “Educating for Change: Teaching Race in a Climate of Hostility.”





APSA Virtual Research Meeting (2024)



The [2024 APSA Virtual Research Meeting](#) was APSA's inaugural online meeting, held on February 8-9, 2024, to explore "**Challenge in Political Science.**" The two-day virtual conference brought together over 400 political science scholars from various career stages and subfields.

The goal of the Virtual Research Meeting is to provide an accessible virtual space for political scientists globally to advance their research and collaborate with fellow political scientists.

The virtual meeting was comprised of [Research Group workshops](#), general sessions and three [keynote panels](#). Across the 9 unique research groups, there were 129 attendees that participated in a series of three related two-hour sessions organized around a common topic.

These workshops were designed to facilitate networks on shared research projects and provide opportunities for intensive discussion and engaged feedback. The three keynote panels were "Understanding the Crisis in Israel and Palestine," "Academic Freedom & Cancel Culture," and "The 2024 U.S. Elections: Déjà vu or the Unexpected?."

The virtual format of this meeting encourages participants to propose innovative topics and panel structures to enhance engagement and spark meaningful discussions.

Participants were invited to propose unique topics, incorporating themes like pedagogy, teaching and learning, academic freedom, or AI in political science, and creative panel formats, such as a panel on Trump's trials with constitutional law scholars and comparativists or dissertation elevator pitch workshops.

Virtual Research Meeting Attendance & Data

- The virtual meeting had almost 450 registrants, with 93% attending the event.
- Approximately 28% of attendees were international and 29% were graduate students.
- The Research Groups had roughly 130 applicants combined, with organizers accepting 78% of applicants. Of the accepted applicants, 88% attended or participated in the Virtual Research Meeting.

Future APSA Meetings

APSA has scheduled future Annual Meetings through 2029 with an additional year in 2032. To promote a more family-friendly atmosphere, APSA, in collaboration with the Council, decided to move the conference dates off its traditional Labor Day weekend when it makes sense financially. The conference rotates around the continent and is held in cities that are easily accessible for participants, while adhering to APSA's siting policy.

The 2025 APSA Annual Meeting will take place in Vancouver, British Columbia.

APSA Diversity, Equity and Inclusion Programming & Updates



Recognizing the many differences of our members — demographic, substantive, intellectual, pedagogical, methodological, and institutional — and leveraging this diversity is critical not only to the success of individual political scientists but to the strength and longevity of the disciplinary enterprise. APSA Diversity and Inclusion Programs provide resources and programs to broaden participation in the profession.

Diversity Fellowship Program

The [APSA Diversity Fellowship Program](#) (DFP) is a fellowship competition that provides support to students applying to, or in the early stages of a PhD program in political science. APSA welcomed 21 new fellows to the program in Spring 2024 and 6 new fellows in Fall 2024. Additionally, the DFP Travel Grant Program provided professional development support for 10 fellows and the Lee Ann Fujii DFP Travel Grant Program supported four fellows' attendance at the 2024 APSA Annual Meeting, thanks to the generous contributions of the Fujii Family and friends and colleagues of the late Dr. Fujii.

Fund for Latino Scholarship

The [Fund's primary goal](#) is to encourage and support the recruitment, retention, and promotion of political science students and scholars who study and research Latina/o politics (especially students and tenure track junior faculty). In 2024, the Fund supported 8 scholars' research and their participation in the 2024 APSA Annual Meeting.

Ralph Bunche Summer Institute

The [Ralph Bunche Summer Institute](#) (RBSI) program, created in 1986, is designed to introduce aspiring political scientists to the world of doctoral study. The RBSI program encourages students to pursue academic careers in political science by enhancing writing, research, and analytical skills to increase competitiveness in the application and financial aid process for graduate school. The 2024 institute, hosted by Duke University, was held in-person with 14 students successfully completing the institute. Seven scholars attended the 2024 Annual Meeting for professional development experiences and to present their research.

APSA Diversity, Equity and Inclusion Programming & Updates

Advancing Research Grants

The [APSA Diversity and Inclusion Advancing Research Grants](#) provide support for research that examines political science phenomenon affecting underserved communities and underrepresented groups. In 2024, the Advancing Research Grants for Early Career Scholars awarded 10 projects, and the Advancing Research Grants for Indigenous Politics supported 22 projects. Recipients were invited to present their research projects at the 2024 Annual Meeting.

Diversity Student Recruitment Program

APSA established the [Diversity Student Recruitment Program](#) (DSRP) to advance diversity in political science. In collaboration with undergraduate and graduate political science departments, the program identifies students and recent graduates who show potential for or are interested in doctoral study and shares this recruitment information with APSA member graduate departments. For the 2024-2025 academic year, there were 43 graduate departments enrolled and 358 students in the database.

Mentoring Program



The [APSA Mentoring Program](#) connects undergraduate students, graduate students, and junior faculty from all backgrounds to experienced and senior members of the profession for professional development support on a wide range of academic and career topics. The Mentoring Program hosted a networking reception during the 2024 APSA Annual Meeting in addition to a Best Practices Roundtable for Mentors and Mentees, which featured advice and guidance from mentors and mentees who previously participated in the Program. A total of 131 mentor matches were made during the spring 2024 and fall 2024 semesters.

“Respectful, Equitable, Safe, Professional, and Ethical Conduct Towards All”

The [APSA RESPECT Campaign](#), created in 2018, encourages “professional respect” by and towards all APSA Annual Meeting attendees and participants at all times. RESPECT stands for “Respectful, Equitable, Safe, Professional, and Ethical Conduct Towards All.” The APSA Sexual Harassment Survey Report and Anti-Harassment Policy (code of conduct) address the importance of facilitating a climate of respect at the annual meeting. The APSA Meetings Ombuds and the onsite DEI or Bystander Intervention training also embody this message. Both resources were available at the 2024 annual meeting.

The [APSA Diversity and Inclusion Advancing Research Grants](#) are a fulfillment of the APSA Strategic Plan to expand support for research that examines political science phenomena affecting underserved communities and underrepresented groups.

In 2024, APSA awarded the fifth annual cycle of Diversity and Inclusion Advancing Research Grants for Early Career Scholars and Indigenous Politics.

The Early Career Scholars Grant supported ten projects for a total award amount of \$20,000.

Advancing Research Grants

The Advancing Research Grants complement APSA's existing diversity and inclusion fellowships and grants—namely the APSA Diversity Fellowship Program (DFP), the Lee Ann Fujii APSA Diversity Fellowship Travel Grant, and the Fund for Latino Scholarship—providing additional research funding opportunities for scholars at multiple points in their professional careers.

Indigenous Politics Grants

The Indigenous Politics Grant supported 22 projects for a total award amount of \$44,000. Previously unused funds were allocated to the Indigenous Politics Grant, leading to an increase in the number of awards made in 2024. Recipients were invited to present their research projects at the 2024 Annual Meeting.

2024 Scholars of the APSA Ralph Bunche Summer Institute (RBSI)



The [Ralph Bunche Summer Institute](#) (RBSI) program, created in 1986, is designed to introduce aspiring political scientists to the world of doctoral study. The RBSI program encourages students to pursue academic careers in political science by enhancing writing, research, and analytical skills to increase competitiveness in the application and financial aid process for graduate school. The 2024 institute, hosted by Duke University, was held in-person with 14 students successfully completing the institute. Top scholars were invited to present their research at the 2024 APSA Annual Meeting.

This video series, ***Contributions by Scholars of Color***, contributes to a continuous project that seeks to amplify the scholarship and contributions of Black, Indigenous, and People of Color to the profession and investigate the history of race and racism in the political science profession.

Interviewees reflected on their upbringing, introduction to political science, and various challenges they faced in their careers, and additionally shared advice for scholars in the discipline.

It further builds upon the APSA-Pi Sigma African American Alpha Oral History Project (1988-1994) and is motivated by the McClain Task Force on Systemic Inequality in the Discipline (2022). This round of interviews premiered at the 2024 APSA Annual Meeting in Philadelphia, Pennsylvania and will be shown at the 2025 NCOBPS Annual Meeting.

Plans are underway for additional interviews in the future.

APSA International Programs



Short Course: Brazilian Political Science Association (ABCP) Conference

In August, APSA collaborated with the Brazilian Political Science Association to offer a half-day short course on “Publishing in High-Impact International Journals in Political Science” prior to their conference in Salvador, Brazil. Leading the session for 20+ junior scholars were Nara Pavão (UFPE) and Michelle Dion (McMaster University), who gave a lecture on the journal submission and review process with insights from APSR.

Middle East and North Africa (MENA) Workshops and Programming

With funding from Carnegie Corporation of New York (CCNY), APSA extended our engagement with early-career scholars from the Arab MENA region. We paired six junior scholars with mentors through the MENA Mentoring Program. In May, we held the second MENA Methods Training Workshop, which ran as a 3-day in-person training in partnership with the Tangier American Legation Museum (TALIM) and the Moroccan Institute for Policy Analysis (MIPA). Twenty-two participants from Morocco and other Arab MENA countries attended the workshop on “Qualitative Methods for the Social Sciences: Causal Analysis.” We also supported 7 scholars from the MENA region to attend the IQMR and ICPSR summer methods training programs in June/July 2024.

This year’s Research Development Workshop, on “The Politics of Identity in the Middle East and North Africa,” was held in partnership with the Center for the Gulf and Arabian Peninsula Studies at Kuwait University from December 14-19, 2024.

JPSA-APSA Working Group on “Civically Engaged Research for Critical Issues in Society”

In collaboration with the Japanese Political Science Association (JPSA), APSA was awarded a grant from the Japan Foundation to support civically engaged research. This multi-year program brings together scholars from American and Japanese universities in a series of conference Working Groups held alongside the APSA and JPSA annual meetings. Together with three senior scholars, approximately 20 fellows share and improve research towards publication, explore best practices and strategies for undertaking civically engaged research, and develop new scholarly networks. Each four-day program includes a unique schedule of lectures, peer review sessions, and meetings with members of local civil society organizations.

The inaugural Working Group, held alongside the 2024 APSA Annual Meeting in Philadelphia, PA, focused on Environmental Politics and featured research from 16 junior scholars (8 from Japan and 8 from USA). Next year’s Working Group will be held alongside the 2025 JPSA Conference in Tokyo.

Annual Meeting Research Development Groups (RDGs)

This year we supported 13 scholars from outside the USA to receive critical feedback on their research via participation in one of two RDGs alongside the 2024 APSA Annual Meeting. The Southeast Asia Politics Research Group (SEAPRG) hold a short course featuring research by six Asian scholars. In addition, two co-leaders from the 2023 MENA Workshop in Cairo organized a follow-up program for seven junior scholars from the MENA region.

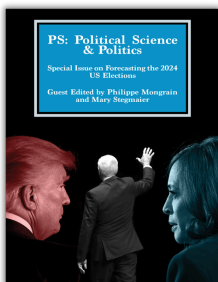
New Editorial Team for the APSR

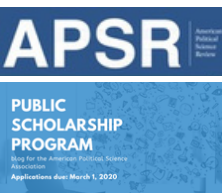

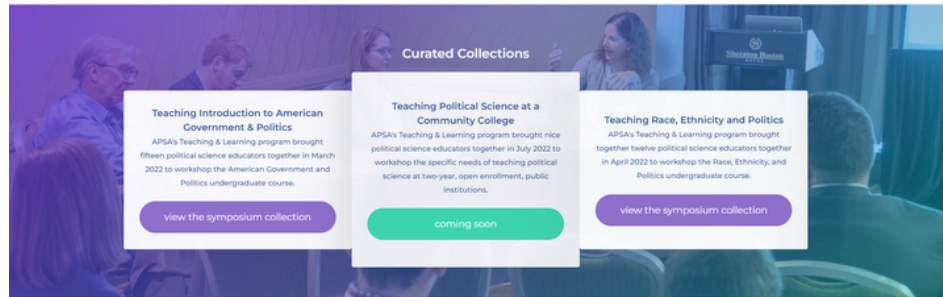

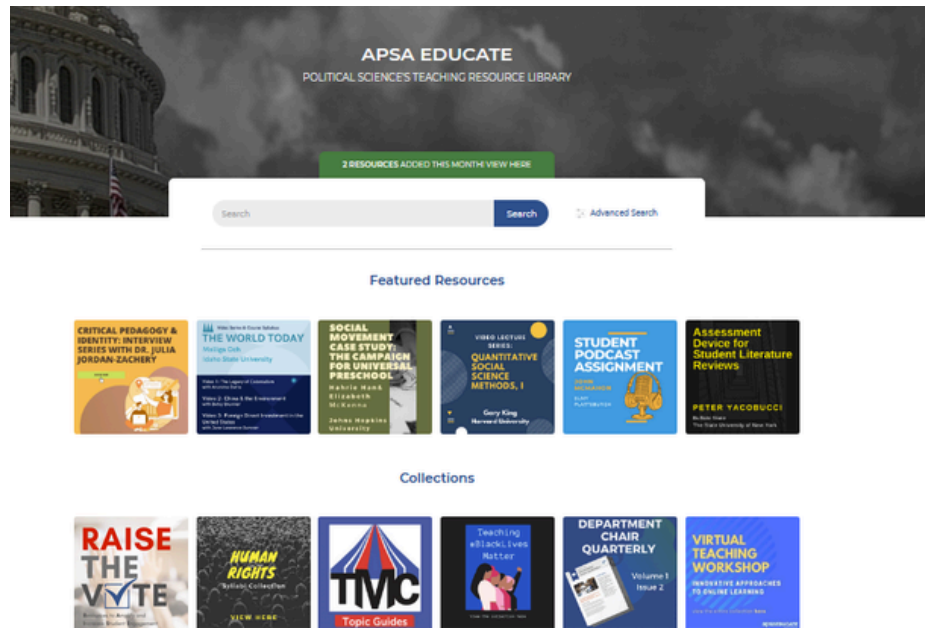

APSA Status Committees

An important part of APSA's professional development work is collaboration with APSA's status committees.

APSA Department Services Program

APSA's Departmental Services Program supports political science departments by providing:

- resources for department chairs, data and reports on the profession,
- forums for departments to address common issues,
- and services for chairs, faculty, and students.

Fifty-seven department chairs attended the 2024 [Department Chairs Mini-Conference](#) held on the Friday of the 2024 Annual Meeting. The mini-conference program included two roundtables and a keynote address.

Interview Services

APSA provides space and facilities for employers who have posted an eJobs listing to interview candidates onsite at the Annual Meeting.

Graduate School Information Fair

The APSA Graduate School Information Fair provided a space at the Annual Meeting for departmental representatives to talk about their programs with prospective students.

Professional Development Roundtable and Workshops

This year's roundtable panels and workshops at the Annual Meeting focused on applying for grants, navigating the academic job market, and succeeding in academic and applied careers.

Career Open House

The Career Open House is an opportunity for APSA Annual Meeting attendees to engage with departments, institutions, and organizations for informational and informal discussions about jobs in political science and other careers that draw on political science training, both on campus and in applied settings. The 2024 Career Open House welcomed over 100 attendees to connect with 10 departments, institutions, and organizations and engage in conversations at "Ask-Me-Anything" tables on getting post-docs, teaching at community colleges, and finding non-academic careers as an international graduate student.

Dissertation Workshops

APSA organizes in-person & virtual [dissertation workshops](#) annually. Our in-person events are held the Wednesday prior to the APSA Annual Meeting. Each full-day workshop includes 6-8 PhD candidates who present a dissertation chapter, along with two faculty members who lead the workshop and moderate discussions. Data on the Profession

APSA's **Research Department** performs [research](#) on the political science profession, focusing on diversity, equity, and inclusion issues within the discipline and higher education. We produce reports on APSA surveys and other data, publish insights into our research, and maintain interactive data dashboards.

Data Requests

APSA's Research Department Responds to requests by members and other stakeholders for data on issues related to the profession and the discipline of political science.

Research Reports

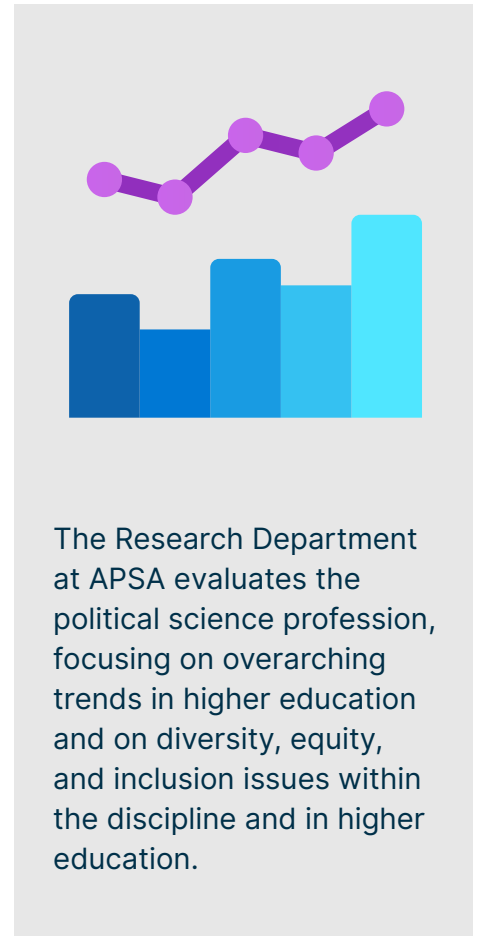
Reports are published on topics pertinent to the political science profession. These reports are publicly available on our website and fall into three main categories: Curriculums; Enrollments and Degrees; and Employment and Salaries.

Research Dashboards

APSA maintains interactive data dashboards as a resource for learning more about APSA's membership and organized sections. These interactive dashboards utilize Tableau software and allow users to visually explore APSA's data.

Research Insights

APSA's research insights visually highlight key research findings and provides insights into other issues of relevance to the political science profession. Insights cover all topics researched by the department.



Accessible Datasets on Political Science Departments

The Research Department creates anonymized datasets on departments (enrollments, curricula, faculties, and salaries/ benefits); on the PhD cohorts and the job market (incoming graduate classes, graduate placements/ hiring trends, and positions advertised), and membership demographics over time. These datasets are publicly available for our members to download on the APSA website.

Easy-to-Share Dashboards on Faculty Trends

The Research Department also created an easily shareable and user-friendly data dashboard on faculty trends in the profession, and enrollments in the discipline, which was made available to departments that shared their data by participating in the 2024 Departmental Survey; this dashboard shows faculty distributions of current and newly hired faculty by department types, degree types, and salaries.



2024 HIGHLIGHTS & CONTRIBUTIONS

35 Grants, Contributions, and Financial Summary

2024 Highlights & Contributions

In 2024, APSA raised \$68,017.05 in total donations, reflecting significant year-over-year growth and underscoring the continued generosity from donors.

Charitable Giving

Total funds raised increased substantially, driven by higher average gift sizes, despite a modest decline in contributions and donors. Stronger giving levels among supporters contributed to a successful fundraising year.



Data Highlights

- The average monthly fundraising total was \$5,672.18 while the median monthly total was \$4,213.71.
- The average donation was \$109.02 while the median donation was \$25.00.
- The month with the highest fundraising total was December with \$15,023.39.
- The largest single donation to the Association in 2024 was \$10,000.00 to establish the Francine Frankel Book Prize.
- September saw the year's lowest monthly fundraising total at \$2,705.00.
- Two funds – the APSA Annual Fund and Ralph Bunche Program Fund – topped the list of individual contributions each receiving support from 68 donors.

First-Generation Scholars Fundraiser

Since 2017, APSA has conducted a week-long fundraising campaign to support First Generation Scholars in the discipline attending the APSA Annual Meeting.

This past October, with matching contributions from the APSA Committee on the Status of First Generation Scholars and additional support from three other APSA Status Committees, the effort raised \$1,470 to provide 38 scholars with travel support reimbursements.

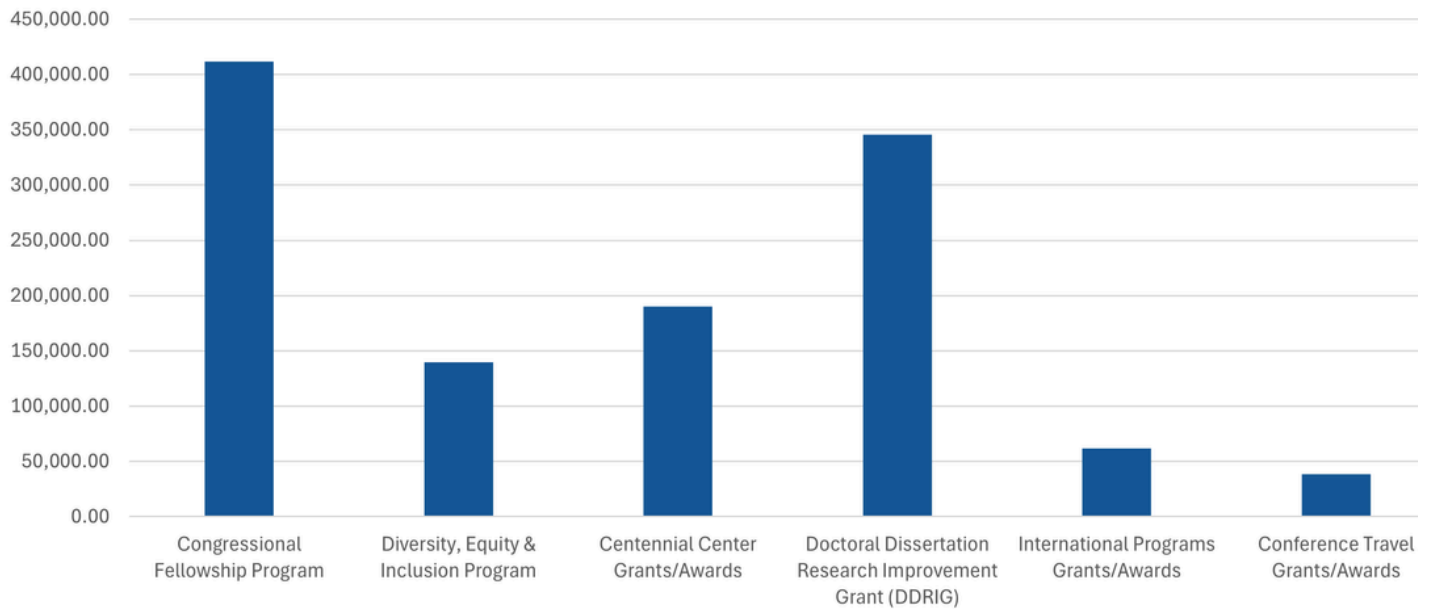
National Forest Foundation Contribution
